A Solution in homophobia in students of Northwestern University

This letter is in regard to homophobia in Northwestern University students. In reference to the research conducted in Northwestern University, it suggested that, there is over hostility of sexual minorities in Northwestern University environment. Further, it is associated with the decrements of student's well-being. The letter addresses the overlook of the possible effects that involves heterosexism in Northwestern University. In addition, the letter emphasizes on how the university undermines the knowledge on heterosexism issues by both men and women. The results of harassment that comes with heterosexism are supposed to be considered significant as asserted in the letter.

According to the research conducted in Northwestern University involving more than three thousand students, the effects of heterosexual harassment among students resulted to poor grades in exams and stigmatization. The research proves that, heterosexual harassment is not taken seriously by the Northwestern University administration thus allowing it to increase tremendously. Victims of the harassment suffer due to ignorance from university administration on the issue. According to the statistics on the heterosexual harassment in Northwestern University, 7 percent of sexual minorities and 39 percent heterosexual students have experienced harassment while 41 percent of student's population in the Northwestern University experienced the harassment. Moreover, the research asserts that, this form of harassment might lead to discrimination of students. Resulting from the research, gays and lesbians believe that heterosexual students discriminate against them. On the other hand, majority face the challenges of discrimination by minorities. As a result, Northwestern University students discriminate against themselves depending on the sexual orientation thus impacting negatively affecting their grades. After being harassed for being heterosexual, the student will face discrimination from individuals who have different sexual orientations.

When a student is discriminated because of being heterosexual, he or she will experience poor well being, poor performance in academics, and poor health. Most Northwestern University students who carried out this research and are at the same time considered as

victims of the harassment have poor health. As noted by researchers, “sexual harassment leads to a form of poor health”, therefore, this will result to sexually transmitted diseases that will in turn lead to poor health. Whenever a student have poor health, he or she will not concentrate in class thus contributing to poor grades and overall performance rated as below average. The gay students are on the other hand alienated in Northwestern University. The research also confirms that, when a student is separated from the others, he might develop bad characters, have poor interactions and create fear and hatred. In the Northwestern University environment, students who are alienated have distress and anxiety thus contributing to aversive emotions from students. The research further exposes alienation as a form of harassment that will limit some behaviors from being expressed. Most students fear expressing certain characters for it is believed that, when the behavior is expressed, it will be used when determining their sexuality leading to alienation and discrimination acts.

The Northwestern University have solutions as the research suggests. Some students positively fight the stigma and report incidences to the university management thus taking measures to control harassment. Also, students are supposed to be mindful and watchful on harmful behavior that might negatively affect others. The Northwestern University staff and administrators are supposed to take serious preventive measures to any form of sexual harassment to eradicate it in Northwestern University. A number of students have suggested that being observant and taking caution to any form of harassment will help in reducing the cases in the university. In addition, the Northwestern University should implement anti-harassment law to fight the act in the university. Lastly, introduction and implementation of ethical code for student’s to interact thus reducing sexual harassment cases.
